Mr. Chapman reported on the following:

- Renovations continue at SML, the punch list is being finalized, which includes the arrival of additional furniture and the final panel for the small conference room
- The SML HVAC project is to finalize the second week of November
- The following quotes were proposed: tree trimming at HH, BF, and WE, data cabling for the new processing room at SML, Sidewalk and Floor Repair Project at BF, and an AV Project, which includes new updated equipment in multiple locations at SML

The meeting adjourned at 5:45pm.

The next regular meeting of the Buildings & Grounds Committee will be held on Wednesday, November 5, 2025 at 5:30pm in the auditorium of the Steele Memorial Library.

Report of the October 1, 2025 meeting of the Executive Committee of the Chemung County Library District:

The meeting came to order at 6:00pm. Attending the meeting from the Executive Committee were Ms. Rachel Dworkin, Ms. Martha Smith, Mr. Mark Padgett, and Ms. Jessica Roberts. Board members attending were Ms. Karen Snyder, Mr. Kevin Hansen, Ms. Pat Kinney, and Mr. Kevin Sullivan. Mr. Paul Chapman and Ms. Holly Melott, CCLD management, were also present.

UNPAID BILLS: Ms. Melott submitted the Unpaid Bill List dated 10/01/2025 for the General Fund in the amount of \$45,990.18. **Ms. Dworkin moved, seconded by Mr. Sullivan, to approve payment of the General Fund in the amount of \$45,990.18. VOTE: Unanimously Approved.** 

Mr. Chapman reported on the following:

- He met with administration from EOP to collaborate and share support services and is looking forward to partnering with them in the future
- A Van Etten patron expressed gratitude for the extended hours
- A CDAR matured, a portion of the monies were reinvested
- He continues to meet with financial consultant, Nancy Kirby, to assess fundraising
  options. She has also recommended that the Krazinski and Denton bequeathals be
  returned to CCLD for direct investing
- He has submitted multiple documents for the policy committee to review
- Quotes for the following were presented: tree trimming at HH, BF, and WE, data cabling for the new processing room at SML, sidewalk repair and book drop installation project at BF, and an AV Project, which includes new updated equipment in multiple locations at SML

Mr. Padgett moved, seconded by Ms. Roberts, that the BF Sidewalk Repair and Book Drop Installation Quote in the amount of \$29,750 be accepted. VOTE: Unanimously Approved.

Mr. Sullivan moved, seconded by Ms. Kinney, that the AV Project Quote, in the amount of \$37, 337, be accepted. VOTE: Unanimously Approved.

Mr. Padgett moved, seconded by Ms. Snyder, that the quote from CPE Interlink for data cabling in the new processing room at Steele for the amount of \$3,836, be accepted. VOTE: Unanimously Approved.

Ms. Dworkin moved, seconded by Mr. Sullivan, that the quote from Jon's Tree Trimming Service in the amount of \$2,500/location, BF, HH, and WE, for a total of \$7,500 be accepted. VOTE: Unanimously Approved.

Ms. Dworkin reported on the following:

- Negotiations continue, a meeting was held on 9/30, additional date(s) are planned for October
- Attorney, Kim Middaugh, is striving to finalize the property purchase in Southport
- Ms. Muriel Friend has moved and no longer resides in the 2<sup>nd</sup> district. The board has accepted her resignation and is deeply grateful for her service. A candidate has been secured to run in the upcoming election.
- Chemung County representatives are being sought for both the Southern Tier Library System Board and the Southern Tier Library System Foundation, inform her if you know of anyone who may be interested
- She has been contacted by someone affiliated with the "*Ithaca Times*". They proposed including CCLD in an online newsfeed. Updates will be shared as they become available.
